3. CITY OF HUMBLE ORDINANCE NO. 07-638 CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 12, 2007 FOR THE PURPOSE OF ELECTING A MAYOR AND TWO COUNCILMEN

ORDINANCE NO. 07-638

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 12, 2007 FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) COUNCILMEN FOR THE CITY OF HUMBLE

WHEREAS, a general election was held in the City of Humble, Texas on May 12, 2007 for the purpose of electing a Mayor and two (2) Councilmen; and

WHEREAS, said election was duly and legally held in conformity with the election laws of the State of Texas and the results of said election have been verified and returned by the proper judges and clerks; and

WHEREAS, it appears that a total of 601 votes were cast in such election; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS:

Section 1. The facts set forth in the preamble of the Resolution are hereby found to be true and correct.
