This letter is to address the public hearing for the renewal of the *City of Humbles' Curfew for Persons Under the Age of 17* to be held, Thursday, April 25, 2013. I have several comments I would like to make about this renewal.

As the Crime Victim Liaison for the City of Humble Police Department and as a Juvenile Program Coordinator for the City of Humble Municipal Court, I believe it is important to keep this curfew in place. Looking at the number of curfew violations will show that there has been an increase in the number of tickets written to juveniles for this violation. Keeping the curfew in effect may help curtail the number of juvenile arrests made for other crimes such as criminal mischief, burglaries and other crimes committed by juveniles. Continuing the curfew may also help reduce truancy. Additionally, with a curfew in place, there is a possibility that it could deter non-delinquent juveniles and others (adults) from becoming crime victims. This ordinance gives the police department a legal tool to help keep juveniles off the streets during those hours deemed not appropriate for them to be on the streets of this city.

Please consider this request to renew the *City of Humbles' Curfew for Persons Under the Age of 17*. Thank you for your consideration.

ORDINANCE NO. 13-717

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, AMENDING CHAPTER 38, SUBDIVISIONS, TO REDUCE THE MINIMUM NUMBER OF OFF-STREET PARKING SPACES REQUIRED AT BOWLING ALLEYS FROM SIX TO FIVE SPACES PER BOWLING LANE; IMPOSING A PENALTY IN AN AMOUNT NOT TO EXCEED \$500 FOR VIOLATION OF ANY PROVISION HEREOF; REPEALING OTHER ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH; AND PROVIDING FOR SEVERABILITY.

* * * * *

Whereas, the City Council believes that the current off-street parking requirements for Bowling Alleys are outdated and should be revised;

Now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, THAT:

Section 1. The facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct.

Section 2. Section 38-29(2)(n) of the Code of Ordinances of the City of Humble, Texas, is hereby amended to read as follows:

“Sec. 38-29. - Off-street parking requirements.

...

(2) *Nonresidential parking requirements.* The following schedule of minimum off-street parking requirements shall apply to all nonresidential construction, new or structurally altered, within the city:

...

n. Bowling alley: ~~six~~ five parking spaces for each bowling lane.”

Section 3. Any person who shall intentionally, knowingly, recklessly, or with criminal negligence, violate any provision of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not to exceed \$500.00. Each day of violation shall constitute a separate offense.

Section 4. In the event any section, paragraph, subdivision, clause, phrase, provision, sentence, or part of this ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Humble, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

Section 5. This Ordinance shall become effective upon final reading and adoption of this Ordinance when the caption hereof is caused to be published once in the official newspaper of the City, by the City Secretary, within ten days after the passage of the ordinance, as required by law and Article II, Section 13 of the City Charter.



Tree Preservation Ordinances:
“Crazy, Asinine, and the Biggest Scam in the State of Texas”

That’s exactly what a state legislator said to city representatives who testified against H.B. 1858 (Workman) on April 2. The bill would allow a property owner to cut down a tree on his property if he believes it poses a fire risk, even if a municipal ordinance prohibits the cutting. The author explained that the reason for the bill was the devastation caused by the recent Bastrop wildfires. Witnesses for the bill showed pictures of homes that were destroyed by fire in part because of the trees surrounding them.

While no one wants to see the proliferation of wildfires, no connection whatsoever was made at the hearing between municipal tree preservation ordinances and increased wildfire risk. In fact, the destroyed homes that were shown in the proponent’s photos weren’t even subject to a municipal tree ordinance.

The bill is an example of a common bait-and-switch tactic at the Capitol. By packaging the measure as “fire mitigation,” attention was diverted from the real issue—desired preemption of municipal authority. That became clear at the hearing when a committee member aggressively questioned a mayor who was there to explain why his city adopted a tree preservation ordinance (answer: because the citizens demanded it) and how it works (answer: it in no way creates a fire hazard). In fact, the mayor’s city is one of only a handful of cities in the state certified as a

“Firewise Community” by the National Fire Protection Association, meaning that the city’s fire protection regulations are among the finest.

“Cities...think they’re smarter than the property owners out in the communities,” the committee member said. Perhaps instead it was a case of a state legislator believing his judgment is superior to that of a mayor and five city councilmembers who were elected to represent their citizens locally.

Religious Freedom?

Ensuring that a Sunday school classroom has smoke detectors does not infringe on anyone’s practice of religion. Requiring the beams and trusses holding up the roof above a church sanctuary to meet engineering standards enables congregations to worship without fear that the ceiling will collapse on them. The same sensible standards apply to places of worship that protect the safety and health of Texans in other buildings they enter. A bill heard this week, H.J.R. 110 (Isaac) would amend the Texas Constitution in a way that would prevent such sensible city requirements.

The resolution seems deceptively simple, but would overturn decades of judicial precedent relating to the right to practice religion. How? By removing one word: “substantially”. The current-law judicial test for determining whether a government practice relating to religion is unconstitutional requires a “substantial burden” on a person’s ability to practice his or her religion. Under that test, uniform and generally-applicable regulations won’t usually be found unconstitutional. For example, a municipal requirement that a place of worship obtain a building permit and comply with uniform building codes won’t be unconstitutional, because it is not a substantial burden on a person’s ability to build a worship facility. By removing “substantially,” H.J.R. 110 would strike down any ordinance that “burdens” religion by even a small amount.

Further, H.J.R. 110 would open the floodgates for lawsuits seeking protection for every kind of bizarre religious practice imaginable. Attempts to enforce animal cruelty laws, child protection laws, health regulations, or public nuisance ordinances against alleged “religious practices” would bring needless litigation.

The Texas Religious Freedom Act as it’s currently written protects religion by balancing that important freedom with public safety concerns. H.J.R. 110 would destroy that balance. Fiscal Transparency Bill's Impact on Certificates of Obligation

H.B. 14 by Representative Jim Pitts (known as the “fiscal transparency” bill) would impose numerous financial reporting requirements on local governments and dramatically restrict cities’ ability to issue certificates of obligation (COs). More specifically, the bill would change the number of voters needed to petition to force an election on the issuance of a CO from five percent of the qualified voters in the city to five percent of the total number of voters who voted in the most recent gubernatorial general election in the city. To see how this would translate for Texas cities, the League surveyed a range of cities on the number of registered voters in the city compared to the number of voters who voted in the 2010 gubernatorial election.

The findings show that usually less than half of a city’s population is registered to vote, but the number of voters who participated in the 2010 gubernatorial election was less than half of the registered voters. For example, a city with a population of 10,000 generally has roughly 5,000 registered voters. Fewer than 2,500 of those voters, however, typically voted in the gubernatorial election. If H.B. 14 passes in its current form, a petition of only 125 people (five percent of those voters) in such a city would be needed to force an election on the issuance of a CO.

If only 125 people in a city of 10,000 can force an election on a CO, nearly anybody could gather the adequate amount of signatures needed within an hour simply by standing outside the local grocery store. This would drastically limit the ability of a city to issue certificates of obligation. Cities turn to COs in lieu of bonds because of their flexibility for small projects or because an emergency requires immediate action.

In addition, many cities use COs instead of revenue bonds to build utility infrastructure projects because cities can save millions of taxpayer dollars in interest payments by issuing a CO, even though the debt service will ultimately be paid by utility revenues alone and not property taxes. H.B. 14 would almost certainly reduce the number of COs issued by cities, which would lead to increased election costs and significantly higher interest payments on debt issuances that must be funded by local taxpayers.

TCEQ Proposes Rainwater Harvesting Rules

The Texas Commission on Environmental Quality (TCEQ) recently released Rule Project Number 2011-057-290-OW, which relates to rainwater harvesting. The text of the proposal is available at:

The proposal implements changes made to the Texas Health and Safety Code in 2011 that were designed to encourage the use of rainwater harvesting.

Though the proposed rules allow a city to refuse to connect a rainwater harvesting system to its utility system, as the 2011 bill permits, the rules place additional burdens on cities that could force them to opt out of rainwater harvesting altogether.

Of particular interest to cities is proposed Section 290.44(j)(3), which requires that – at each residence or facility where water from a rainwater harvesting system is used for indoor potable purposes and where there is a connection to a public water system (PWS) – the PWS is responsible for ensuring that minimum treatment requirements are met. Additionally, proposed Section 290.109(h) tasks a PWS with ensuring that the microbiological quality of the treated rainwater is monitored at least annually.

Internet Notice Bill Heard in House Committee

On April 1, the House Committee on Government Efficiency and Reform heard H.B. 3646 by Representative Linda Harper-Brown. The bill would give a city the discretion to provide public notices on its Internet website rather than paying for newspaper publication if the website reaches more readers. Rep. Harper-Brown had hardly begun laying out her bill in her committee before other committee members began to attack her idea as harmful to local newspapers.

The vociferous opposition to the bill by members of the committee was surprising. The fact that many newspapers and related associations attended the hearing to testify against it was not. Opponents argued that eliminating a print publication requirement dramatically reduces government transparency. Of course, that argument ignores the fact that print newspaper readership is declining every year. A 2012 study by the Pew Research Center found that only 23 percent of Americans read print newspapers, and that number had declined by 18 percent over a ten-year period. Burying a public notice in a newspaper that not even a quarter of the citizens read would not appear to promote government transparency.

The League joined other local officials to testify in support of the bill. Testimony showed that not only would H.B. 3646 increase government efficiency by potentially saving cities and taxpayers thousands of dollars, it would actually *increase* transparency by requiring a city to use whichever medium, be that a newspaper or the Internet, that reaches the largest number of residents.

TML Names Legislator of the Month for March

Representative Mike Villarreal (D – San Antonio) is the TML Legislator of the Month for March 2013. Representative Villarreal represents House District 123, which includes San Antonio and Castle Hills.

First elected to the Texas House in 2000, Representative Villarreal is serving in his seventh term and chairs the House Committee on Investments and Financial Services. He also serves on the House Committee on Public Education.

Representative Villarreal is a strong supporter of cities and local control. Most recently, Representative Villarreal filed an amendment to Senate Bill 1, the state appropriations bill, that would appropriate an additional \$15 million for local parks grants. He is also an outspoken critic of attempts to erode municipal authority. In 2011, *Texas Monthly* named Representative Villarreal as one of the ten best state legislators.



We hope municipal leaders across Texas, and particularly those in Representative Villarreal's district, express their appreciation to this outstanding leader.

Significant Floor Actions

H.B. 4 (Ritter), relating to the creation and funding of the state water implementation fund for Texas to assist the Texas Water Development Board in the funding of certain water-related projects. Passed the House. As passed by the House, the bill would provide that: (1) the state water implementation fund for Texas is created as a special fund outside the state treasury; (2) the fund consists of: (a) money transferred or deposited to the credit of the fund by law; (b) the proceeds of any fee or tax imposed by this state that the legislature by statute dedicates for deposit to the credit of the fund; (c) any other revenue that the legislature by statute dedicates for deposit to the credit of the fund; (d) interest earned on the balance of the fund; and (e) money transferred to the fund under a bond enhancement agreement; (3) a newly-created Texas Treasury Safekeeping Trust Company shall manage and invest the fund, maintaining sufficient liquidity to meet the needs of the fund and adopting a written investment policy appropriate for the fund; (4) at the direction of the Texas Water Development Board, the trust company shall make disbursements from the fund to another fund or account pursuant to a bond enhancement agreement in the amounts the board determines are needed for debt service payments on or security provisions of the board's general obligation or revenue bonds; (5) of the money disbursed from the fund, the board shall apply not less than: (a) 10 percent to support projects included in the state water plan that are designed to serve rural areas and (b) 20 percent to support projects included in the state water plan that are for water conservation or reuse; (6) the board shall use money from the fund to provide financing to projects that prioritize using historically underutilized businesses; (7) the board may direct the trust company to enter into bond enhancement agreements to provide a source of revenue or security for the payment of the principal or interest on bonds issued by the board to finance or refinance projects included in the state water plan if the proceeds of the sale of the bonds have been or will be deposited to the credit of: (a) the state water implementation fund; (b) the water infrastructure fund; (c) the rural

water assistance fund; (d) the Texas Water Development Fund II state participation account; or (e) the agricultural water conservation fund; (8) the board may direct the trust company to make disbursements for the support of bonds, including certain bonds issued before September 1, 2013; (9) each regional water planning group shall prioritize projects in its respective region and the board shall prioritize projects in the state water plan; (10) the State Water Implementation Fund for Texas Advisory Committee is created and is composed of the comptroller, three members of the senate appointed by the lieutenant governor, and three members of the house appointed by the speaker of the house; (11) the advisory committee shall submit recommendations to the board regarding the use of money in the fund for use by the board; (12) money in the state water implementation fund for Texas may be used only to provide financing or refinancing for projects included in the state water plan; and (13) financing or refinancing of projects may be provided by using money in the fund to make loans or purchase bonds below prevailing market rates.

S.B. 249 (Patrick), relating to the prosecution of the offense of breach of computer security. Passed the Senate.

S.B. 360 (Watson), relating to methods used by an animal shelter to euthanize a dog or cat. Passed the Senate.

S.B. 366 (Taylor), relating to the authority of political subdivisions to offer certain deferred compensation plans to employees. Passed the Senate.

S.B. 471 (Ellis), relating to technological efficiencies in the recording of certain open meetings. Passed the Senate.

S.B. 1110 (Nichols), relating to the purposes and designation of a transportation reinvestment zone. Passed the Senate.

Significant Committee Actions

H.B. 77 (Guillen), relating to verification of financial responsibility by peace officers before issuing certain citations. Reported from the House Committee on Transportation.

H.B. 200 (Murphy), relating to liability of certain electric utilities that allow certain uses of land that the electric utility owns, occupies, or leases. Reported from the House Committee on Judiciary and Civil Jurisprudence.

H.B. 239 (Guillen), relating to the use of a wireless communication device or other portable electronic device to provide evidence of motor vehicle financial responsibility. Reported from the House Committee on Technology.

H.B. 278 (Craddick), relating to the liability of a municipality for certain space flight activities. Reported from the House Committee on Judiciary and Civil Jurisprudence.

H.B. 483 (Aycock), relating to a public hearing held on the issue of making a payment in excess of the compensation contracted for by a political subdivision. Reported from the House Committee on Government Efficiency and Reform.

H.B. 489 (Menendez), relating to the use of assistance animals that provide assistance to persons with disabilities; providing criminal penalties. Reported from the House Committee on Defense and Veterans' Affairs.

H.B. 516 (Pitts), relating to the execution of a search warrant for taking a blood specimen from certain persons in certain intoxication offenses. Reported from the House Committee on Criminal Jurisprudence.

H.B. 528 (S. Turner), relating to the restriction of access to the records and files of a child charged with or convicted of certain fine-only misdemeanor offenses. Reported from the House Committee on Corrections.

H.B. 545 (J. Davis), relating to the authority of a municipality to authorize the creation of a spaceport development corporation. Reported from the House Committee on Special Purpose Districts.

H.B. 858 (Lucio), relating to methods used by an animal shelter to euthanize a dog or cat. Reported from the House Committee on Environmental Regulation.

H.B. 1019 (Patrick), relating to conforming the eligibility under a major events trust fund of a National Collegiate Athletic Association Division I Football Bowl Subdivision postseason event with the changes to the Bowl Championship Series system. Reported from the House Committee on Economic and Small Business Development.

H.B. 1222 (C. Turner), relating to venue for certain alleged violations or offenses under the Water Safety Act. Reported from the House Committee on Culture, Recreation, and Tourism.

H.B. 1485 (Lavender), relating to money allocated under the federal-aid highway program. Reported from the House Committee on Transportation.

H.B. 1716 (Pickett), relating to the purposes and designation of a transportation reinvestment zone. Reported from the House Committee on Transportation.

H.B. 1744 (Elkins), relating to authorizing local governments to participate in statewide technology centers. Reported from the House Committee on Technology.

H.B. 1960 (Cortez), relating to reciprocity for emergency medical services personnel certification for certain United States military personnel. Reported from the House Committee on Defense and Veterans' Affairs.

S.B. 302 (Seliger), relating to the management, operation, rulemaking authority, and oversight of groundwater conservation districts. Reported from the Senate Committee on Natural Resources.

S.B. 656 (Paxton), relating to providing transparency in the taxing and budgeting process of certain local governments. Passed the Senate Committee on Open Government.

S.B. 965 (Williams), relating to the correction of employment termination reports for law enforcement officers. Reported from the Senate Committee on Criminal Justice.

S.B. 983 (Ellis), relating to in camera review and filing of the information at issue in a suit filed under the public information law. Reported from the Senate Committee on Open Government.

S.B. 987 (Hegar), relating to requiring the attorney general to obtain an injunction against a municipality or county that adopts prohibited regulations regarding firearms, ammunition, or firearm supplies. Reported from the Senate Committee on Agriculture, Rural Affairs and Homeland Security.

S.B. 997 (Deuell), relating to the sales and use tax consequences of economic development agreements in certain municipalities. Reported from the Senate Committee on Economic Development.

S.B. 1114 (Whitmire), relating to the prosecution of certain misdemeanor offenses committed by children and to school district law enforcement. Reported from the Senate Committee on Criminal Justice.

S.B. 1169 (Hegar), relating to water conservation. Reported from the Senate Committee on Natural Resources. [Note: this bill would require cities that receive state water aid or grants to spend a portion of that aid to mitigate water loss. Concerned cities should read the bill carefully.]

S.B. 1297 (Watson), relating to written electronic communications between members of a governmental body. Reported from the Senate Committee on Open Government. As reported from the committee, the bill would: (1) provide that a communication or exchange of information between members of a governmental body about public business or policy over which the body has supervision or control does not constitute a meeting or deliberation for purposes of the Open Meetings Act if: (a) the communication is in writing; (b) the writing is posted to an online message board or similar Internet application that is viewable and searchable by the public; and (c) the communication is displayed in real time and displayed on the online message board or similar Internet application for no less than 30 days after the communication is first posted; (2) as to the online message board or Internet application described in (1), above: (a) prohibit the governmental body from having more than one; (b) require that it be owned or controlled by the governmental body, prominently displayed on the body's primary Internet web page, and be no more than one click away from that primary Internet web page; (c) allow it to be used only by members of the governmental body or their staff members who have received authorization from a member of the governmental body; and (d) require that a staff member who posts a communication include their name and title; (3) require a governmental body to maintain a posting on an online message board or Internet application as described in (1), above, for six years if a communication is removed that has been posted for at least 30 days, and provide that

the communication is public information that must be disclosed in accordance with the Public Information Act; (4) prohibit a governmental body from voting or taking any action that is required to be taken at a meeting by posting a communication to an online message board or Internet application as described in (1), above; and (5) provide that, in no event, shall a communication or posting on an online message board or Internet application described in (1), above, be construed to be an action of the governmental body.

Call to Action: Several Detrimental Bills on the Move

Legislators have begun trying to move their bills through the legislative process in earnest, and many of the bills would erode city authority or impose an unfunded mandate:

- **Land Acquisition:** Two bills, H.B. 1250 (Frank) and H.B. 20 (Kolkhorst), would drag the routine purchase of land by a city into the realm of “eminent domain reform.” Legislators, and some city officials, strongly supported eminent domain reforms prohibiting the use of the power for economic development. The same goes for last session’s process reforms that protect property owners from abuses. The two bills this session are cleverly disguised to look like eminent domain reform, but they are not about eminent domain at all.

The bills would provide that private property acquired through eminent domain *or through purchase in connection with an initial offer* must be initially used for the public use for which it was acquired. Cities frequently save taxpayer funds by acquiring property ahead of development because they anticipate various public functions that will be needed for an area. For example, a city may purchase land for future fire or police stations or for other municipal buildings. Or a city may purchase easements for utility lines. When a city makes those purchases, it is not required to make a determination of what the exact use will be. The public policy behind allowing a city to make general purchases as would any other buyer in the market is to save taxpayer funds.

H.B. 20 and H.B. 1250 would require a city to bind itself to use in a certain way property purchased on the open market in an arms-length transaction. Both bills were referred to

the House Committee on Land and Resource Management. H.B. 20 was heard on April 15 and is pending. H.B. 1250 was heard on March 4 and was voted out of the committee on April 16. It now moves to the House Committee on Calendars.

- **Tree Preservation:** H.B. 1858 (Workman) would: (1) provide that a city, county, or other political subdivision may not enact or enforce any regulation that restricts the ability of a property owner to remove a tree or vegetation on the owner's property that the owner believes poses a risk of fire to a structure on the property or adjacent property; (2) exempt the City of San Antonio from the bill; and (3) exempt from the bill: (a) regulations relating to property being developed under a municipal permit; (b) regulations governing certain large trees; and (c) regulations designed to mitigate tree-borne diseases as recommended by the Texas A&M Forest Service.

The bill would, for all practical purposes, allow a property owner to clear cut trees even if a city's ordinance prohibits that activity. The bill is framed as a "fire safety bill," but city tree preservation ordinances rarely, if ever, limit a property owner's ability to perform true fire mitigation activities. H.B. 1858 was heard in the House Business and Industry Committee on April 2 and was reported from that committee on April 15.

- **Billboard Relocation:** H.B. 2244 (Harper-Brown) would provide that a city must pay compensation to a billboard owner if a billboard has to be removed from a city or a city's extraterritorial jurisdiction because: (1) of the widening, construction, or reconstruction of a highway that is part of a *state highway* project; and (2) it cannot be moved to another place in the city because of a city billboard ordinance. When the Texas Department of Transportation (TxDOT) obtains right-of-way for highway projects, it must pay for that right-of-way or use eminent domain to acquire it. Requiring a city to pay the costs to condemn a billboard that can't remain in place due to a state highway project is an unfunded mandate.

H.B. 2244 was heard in the House Committee on Urban Affairs on April 10 and was voted out of the committee on April 17.

- **Civil Service:** H.B. 1312 (Fletcher) would require immediate reinstatement to a fire or police position for civil service suspensions while a city appeals the reinstatement order of a hearing officer or civil service commission.

Why is that a problem? When a city feels the need to challenge a civil service reinstatement in court, it's often because the suspension was for a reason—dishonesty, criminal misconduct, or inappropriate sexual conduct—that would make immediate reinstatement impractical or risky. H.B. 1312 was heard in the House Committee on Urban Affairs on March 20 and the committee report was sent to the House Committee on Calendars on April 5.

League staff and city officials testified against all the bills above. Nevertheless, each (except for H.B. 20) has been voted out of a House committee. If your city has concerns, now is the time to

Online Hotel Booking Class Action: Federal Judge Issues Final Judgment

On April 4, U.S. District Judge Orlando Garcia issued a final judgment requiring online hotel booking companies to pay 173 Texas cities more than \$55 million in back taxes, plus penalties and interest. The final judgment represents yet another victory for Texas cities in a case that has been ongoing for more than four years.

In 2009, a federal jury ruled in favor of the cities in their class action lawsuit against the online hotel booking companies. The jury awarded \$20.6 million to the cities based on their argument that the online companies failed to remit city hotel occupancy tax on the “markup” difference between the amount the companies paid for the rooms and the price at which they sold the rooms to consumers.

In 2011, Judge Garcia entered his post-trial findings of fact and conclusions of law. Reinforcing the jury’s determination that the online travel companies are obligated to pay more in hotel taxes to cities, the judge found that cities were entitled to additional actual damages that accrued since the jury verdict in 2009, ordering the online companies to adjust their business practices to ensure the proper payment of taxes on post-judgment transactions.

Although the recent final judgment by Judge Garcia is promising, the dispute is probably still not over. An appeal by the online travel companies to the Fifth Circuit Court of Appeals is likely.

Significant Floor Actions

H.B. 200 (Murphy), relating to liability of certain electric utilities that allow certain uses of land that the electric utility owns, occupies, or leases. Passed the House.

H.B. 1222 (C. Turner), relating to venue for certain alleged violations or offenses under the Water Safety Act. Passed the House.

H.B. 1290 (Phillips), relating to the authority for local governments to jointly administer transportation reinvestment zones. Passed the House.

S.B. 262 (Huffman), relating to the reporting of criminal disposition completeness percentage data. Passed the Senate.

S.B. 476 (Hinojosa), relating to installment agreements for the payment of delinquent ad valorem taxes. Passed the Senate.

S.B. 656 (Paxton), relating to providing transparency in the taxing and budgeting process of certain local governments. Passed the Senate.

S.B. 904 (Van de Putte), relating to the adoption of certain voting procedures and the modification of certain election deadlines, including those necessary to implement the federal Military and Overseas Voter Empowerment Act. Passed the Senate. As passed by the Senate, the bill would, among other things: (1) require the secretary of state to make a checklist or similar guidelines available for optional use by early voting clerks in processing an application and providing balloting materials to a military or overseas voter; (2) extend the deadline for a candidate to withdraw from an election or be declared ineligible and have his or her name removed from the ballot from 5:00 p.m. on the third day after the deadline for applications for a place on the ballot to the fifth day after the deadline for applications for a place on the ballot; and (3) repeal the authority of the secretary of state to adjust or modify election dates or procedures affected by the state implementation of the federal Military and Overseas Voter Empowerment Act.

S.B. 997 (Deuell), relating to the sales and use tax consequences of economic development agreements in certain municipalities. Passed the Senate.

S.B. 1623 (Hinojosa), relating to discovery in a criminal case. Passed the Senate.

Significant Committee Actions

H.B. 2720 (Ritter), relating to the applicability of the law governing emergency authorizations by the Texas Commission on Environmental Quality for the use of state water to certain emergency orders concerning water rights issued by the executive director of the commission. Reported from the House Committee on Natural Resources. As reported from committee, the bill relates to emergency orders made during a period of drought or other emergency shortage of water and would provide that: (1) the executive director of the Texas Commission on Environmental Quality may temporarily adjust the diversions of water by water rights holders only to address an imminent hazard to public health, safety, or welfare; and (2) a diversion may not be granted until a method for calculating and remitting the compensation due to the water rights holder who is subject to the diversion has been agreed on by the holder of the water right.

H.B. 258 (Simmons), relating to the regulation of electioneering at a polling location. Reported from the House Committee on Elections. As reported from committee, the bill would: (1) prohibit a city that owns a building used as a polling place from prohibiting electioneering – including posting, use, or distribution of political signs or literature – on the building’s premises outside the prescribed limits within which electioneering is prohibited during early voting and on election day; but (2) authorize the city to enact reasonable regulations concerning the time, place, and manner of electioneering.

H.B. 889 (Fallon), relating to the requirement that certain governmental bodies broadcast meetings on the Internet. Reported from the House Committee on Technology.

H.B. 928 (Krause), relating to the enforcement of certain federal laws regulating firearms, firearm accessories, and firearm ammunition within the State of Texas. Reported from the House Select Committee on Federalism and Fiscal Responsibility. (Note: this bill would place numerous restrictions on a city’s ability to enforce federal firearms laws.)

H.B. 970 (Rodriguez), relating to regulation of cottage food products and cottage food production operations. Reported from the House Committee on Public Health.

H.B. 1250 (Frank), relating to the initial use of certain properties acquired for a public use. Reported from the House Committee on Land and Resource Management.

H.B. 1600 (Cook), relating to the continuation and functions of the Public Utility Commission of Texas, to the transfer of certain functions from the Texas Commission on Environmental Quality to the Public Utility Commission of Texas, to the rates for water service, and to the functions of the Office of Public Utility Counsel. Reported from the Senate Business and Commerce Committee. This is the Public Utility Commission (PUC) Sunset bill. Of particular interest to cities, the bill as reported from committee would continue the functions of the PUC until 2023 and would: (1) increase the PUC’s oversight of the Electric Reliability Council of Texas; (2) on September 1, 2014, transfer to the PUC the powers, duties, functions, programs, and activities of the Texas Commission on Environmental Quality (TCEQ) relating to the economic regulation of water and sewer service, including the issuance and transfer of certificates of convenience and necessity, the determination of rates, and the administration of hearings and proceedings involving those matters; (3) divide investor owned water utilities in three classes as follows: (a) “Class A utility” means a public utility that provides retail water or sewer utility service through 10,000 or more taps or connections; (b) “Class B utility” means a public utility that provides retail water or sewer utility service through 500 or more taps or connections but fewer than 10,000 taps or connections; and (c) “Class C utility” means a public utility that provides retail water or sewer utility service through fewer than 500 taps or connections; (4) make various changes relating to the water rate process for each class of utility; (5) provide that, by August 1, 2014, the TCEQ and the PUC shall enter into a memorandum of understanding that governs the transition; and (6) authorize the Office of Public Utility Counsel to represent the interests of residential and small commercial water consumers.

H.B. 1858 (Workman), relating to a property owner's right to remove a tree or vegetation that the owner believes poses a fire risk. Reported from the House Committee on Business and Industry. As reported from committee, the bill would: (1) provide that a city, county, or other political subdivision may not enact or enforce any ordinance, rule, or other regulation that restricts the ability of a property owner to remove a tree or vegetation on the owner's property that the owner believes poses a risk of fire to a structure on the property or adjacent property; (2) exempt the City of San Antonio from the bill; and (3) exempt from the bill: (a) regulations relating to property being developed under a municipal permit; (b) regulations governing certain large trees; and (c) regulations designed to mitigate tree-borne diseases as recommended by the Texas A&M Forest Service.

H.B. 2172 (Bohac), relating to the content of photographic traffic monitoring system signs. Reported from the House Committee on Transportation.

H.B. 3857 (Lucio), relating to periodic rate adjustments by water and sewer utilities. Reported from the House Committee on Natural Resources.

H.J.R. 87 (Munoz), proposing a constitutional amendment authorizing a home rule municipality to provide in its charter the procedure to fill a vacancy on its governing body for which the unexpired term is 24 months or less. Reported from the House Committee on Urban Affairs.

S.B. 837 (Ellis), relating to the authority of a municipality to require owners of real property to keep the property free of certain conditions. Reported from the Senate Committee on Intergovernmental Relations.

S.B. 1364 (Schwertner), relating to the computation of an electric utility's income taxes. Reported from the Senate Committee on Business and Commerce.

S.B. 1419 (West), relating to funding for juvenile case managers through certain court costs and to the establishment of the truancy prevention and diversion fund. Reported from the Senate Jurisprudence Committee. As reported, the bill would: (1) require the clerk of a municipal court to collect a \$2 state court cost from all persons convicted of an offense, other than an offense relating to a pedestrian or the parking of a motor vehicle, for the truancy prevention and diversion fund; and (2) allow the city to retain 50 percent of the funds collected for the purpose of operating or establishing a juvenile case manager program.

S.B. 1510 (Hinojosa), relating to the public notice required to be provided by certain taxing units before adopting an ad valorem tax rate. Reported from the Senate Committee on Intergovernmental Relations. As reported, the bill would: (1) provide a new and simplified method of publishing notice of property tax rates to replace the method in current law, except that a taxing unit with a low tax levy as defined by the Tax Code may continue to use the current method of providing notice of a proposed tax rate; (2) require that the notice to be provided by a city that does not adopt a property tax rate that exceeds the lower of the effective tax rate or the rollback rate contain specific language relating to: (a) the proposed rate, preceding year's rate, and effective tax rate; (b) the amount of taxes owed by each individual taxpayer; and (c) contact information for the tax assessor-collector; (3) require that the notice to be provided by a city that

adopts a property tax rate that exceeds the lower of the effective tax rate or the rollback rate contain specific language relating to: (a) the proposed rate, preceding tax year's rate, effective tax rate, and rollback rate; (b) the amount of taxes owed by each individual taxpayer; (c) contact information for the tax assessor-collector; and (d) notice of two public hearings on the tax rate; (4) require a city to publish notice under (2) or (3), above, not later than September 1 in a newspaper having general circulation in the county in which the city is located that may not be smaller than one-quarter page of a standard-size or tabloid-size newspaper with a headline that must be in 24-point or larger type; (5) require a city to post notice under (2) or (3), above, on the Internet website of the city, if applicable, beginning not later than September 1 and continuing until the city adopts a tax rate; and (6) require a city to provide certain tax rate information required by the Tax Code upon request.

S.B. 1596 (Zaffirini), relating to the annexation by a municipality of territory of an emergency services district. Reported from the Senate Committee on Intergovernmental Relations. As reported from committee, the bill relates to a city's removal of territory from an emergency services district and would provide that a city's annexation service plan may not: (1) provide services in the area in a manner that would have the effect of reducing by more than a negligible amount the level of fire and police protection and emergency medical services provided within the area before annexation; or (2) cause a reduction in fire and police protection and emergency medical services within the area to be annexed below that of areas within the corporate boundaries of the municipality with similar topography, land use, and population density.

City-Related Bills Filed

MUNICIPAL COURTS

S.B. 1896 (Garcia) – Municipal Judge: would provide that information contained in property tax appraisal records that identifies the home address of a municipal judge is confidential.

TRANSPORTATION

S.J.R. 65 (Seliger) – Transportation Funding: would: (1) create the transportation infrastructure fund as a special fund in the state treasury; (2) provide that, in each fiscal year, the comptroller shall transfer three percent of the amount sent to the state's economic stabilization fund (the state's "Rainy Day Fund") to the transportation infrastructure fund; and (3) provide that the transportation infrastructure fund may be used only for the purpose of assisting counties in this state in the construction, reconstruction, or maintenance of transportation infrastructure that is intended to alleviate degradation caused by the exploration, development, or production of oil or gas.

UTILITIES AND ENVIRONMENT

S.B. 1894 (Fraser) – Environmental Flow Standards: would: (1) require the Texas Commission on Environmental Quality (TCEQ) to provide a rulemaking process for each river

basin and bay system that has not adopted environmental flow standards; and (2) require TCEQ to evaluate the status of the work plans submitted by the basin and bay area stakeholder committees.
